

Takeaways from this Year's Point in Time Count

Overall: The number of people who are homeless (695) is almost exactly the same as last year (693). This number includes people who are unsheltered, in emergency shelter, or in site-based transitional housing (they have to move when the program ends).

Unsheltered: Unfortunately, the number of people who were unsheltered (outside, in a car, trailer with no electricity or running water, etc.) climbed from **190 last year to 217 this year**. Within this number there was a large drop in the number of individuals and a large increase in the number of families (the reverse of last year's trend). **The number of people in unsheltered families climbed from 34 last year to 107 this year (11 households to 37).**

A closer examination of the unsheltered families shows large increases in the amount at Evergreen School District and at Project Homeless Connect. We have no further HMIS information about the school district families, because they are not able to share identifying information with us. Of the families at Project Homeless Connect, only 1 of the 15 families had no other service history in HMIS. 13 of the 15 families have had contact with the Housing Solutions Center (either before or after Project Homeless Connect). At least 6 of the families are now in permanent housing, 2 are on the waitlist for housing, 1 had been placed into transitional housing, but was terminated from the program, and 1 was living in a motel and shouldn't have been counted as unsheltered.

Chronic homelessness: The number of **chronically homeless individuals dropped from 71 last year to 60 this year**. The number of people in **chronically homeless families jumped from 8 last year to 20 this year**. We know that at least 3 of the 6 chronically homeless families are now in housing.

Homelessness under school definition: People who are doubled-up or couch surfing count as homeless under the school definition, but not under the Point in Time definition. The crisis of homelessness/housing instability in our schools continues to as there were 768 school children who were doubled-up or couch surfing.
