The PSH Northwest II program is a permanent-supportive housing (PSH) program that will serve 4 households (both individuals and families) who are chronically homeless (CH) and are high utilizers of psychiatric, medical, and other community system resources. Referrals will be provided through the Coordinated Entry System, The Housing Solutions Center (HSC). The purpose of the PSH Northwest II program is to provide an opportunity for this population to obtain and remain in permanent housing. Supportive case management services will be provided to assist program participants to increase skills and income, maintain housing stability, and improve opportunities for self-determination. The program's supportive housing case management services are designed to help program participants reduce barriers that cause housing instability. Comprehensive needs assessments identify the specific barriers and weaknesses that inhibit stability. Individual housing stability plans outline the goals for remaining stable in housing. Participants receive information/referrals to community resources/programs for increasing skills and income to broaden opportunities for self-reliance. Case managers assist with applications and provide opportunities for program participants to access medical and mental health services, substance abuse programs, public funding and entitlement benefits, supported employment and other community resources. CSNW staff will continue to monitor and provide guidance for the duration of the participants time in the program.

Dedicated and DedicatedPLUS

A "100% Dedicated" project is a permanent supportive housing project that commits 100% of its beds to chronically homeless individuals and families, according to NOFA Section III.3.b.

A "DedicatedPLUS" project is a permanent supportive housing project where 100% of the beds are dedicated to serve individuals with disabilities and families in which one adult or child has a disability, including unaccompanied homeless youth, that at a minimum, meet ONE of the following criteria according to NOFA Section III.3.d:

- (2) residing in a transitional housing project that will be eliminated and meets the definition of chronically homeless in effect at the time in which the individual or family entered the transitional housing project;


To Whom It May Concern:

The Clark County Sheriff's Office operates a Jail Reentry Program to assist inmates releasing to our community in accessing services and resources that promote safe, healthy, law-abiding lifestyles. Through this effort, we have found that often the key to success is the availability of suitable housing. Community Services Northwest (CSNW) is an important partner in this effort.

The Clark County Jail has committed in-kind support for CSNW's housing programs since 2014. This in-kind leverage was provided in the form of office space in the jail provided to CSNW staff to conduct outreach, screen, and assess eligible participants for their programs. The Clark County Jail also provided security and supervision of all program activities within the jail. The monetary value of these services is estimated at \$10,000 per year.

The Clark County Sheriff's Office is prepared to continue to commit in-kind leverage valued at \$10,000 per year for the continuation of CSNW's housing programs, including The Way Home Too, The Way Home III, PSH Northwest, and PSH Northwest II. This commitment will be provided from 10/01/2018 to the end of the grants in October 2019.
