Client doesn't know (HUD)	You asked the client where they were going, and they don't know where they will be sleeping tonight	
Client refused (HUD)	You asked the client where they were going, and they were unwilling to tell you	
Data not collected (HUD)	Unused in Clark County—see "No exit interview completed"	
Deceased (HUD)	The client has been exited from program due to their death	
Emergency shelter, incl. hotel/motel paid for w/ ES voucher, or RHY-funded Host Home shelter (HUD)	The client will be staying at another shelter, here or somewhere else.  - This includes SafeChoice	
Foster care home or foster care group home (HUD)	The client is currently in a foster home and expected to be there at least the night of program exit	
Hospital or other residential non-psychiatric medical facility (HUD)	The client is currently admitted to the hospital for non-psychiatric reasons and is expected to be there at least the night of program exit	
Host Home (non-crisis) (HUD)	Unused in Clark County—we have no host homes	
Hotel or motel paid for without emergency shelter voucher (HUD)	On the night of program exit, the client will be staying in a hotel that has been paid for by one of the following:  A) the client  B) a person the client knows  C) an organization that does not routinely pay for hotel vouchers as a shelter solution	
Jail, prison or juvenile detention facility (HUD)	The client is currently incarcerated and expected to be there at least the night of program exit	
Long-term care facility or nursing home (HUD)	The client has moved into a care facility or nursing home

Moved from one HOPWA funded project to HOPWA PH (HUD)	Unused in Clark County—we have no HOPWA programs

No exit interview completed (HUD)	You were unable to contact the client to ask them where they will be staying the night they exit program.  - If they re-enter program later and you are able to determine where they went the night you entered "No exit interview completed," please update that destination based on the new information
Other (HUD)	This is rarely necessary. Always check with the HMIS team before selecting this option
Owned by client, no ongoing housing subsidy (HUD)	The client has bought and moved into a home they own, and they have no regular mortgage assistance through a program
Owned by client, with ongoing housing subsidy (HUD)	The client has bought and moved into a home they own, and they have regular mortgage assistance through a program
Permanent housing (other than RRH) for formerly homeless persons (HUD)	The client has moved into a permanent supportive housing unit
Place not meant for habitation (HUD)	The client will be literally homeless the night they are exited from program. This includes clients that are enrolled in housing programs but have not yet moved into a unit
Psychiatric hospital or other psychiatric facility (HUD)	The client is currently admitted to the hospital specifically for psychiatric reasons and is expected to be there at least the night of program exit
Rental by client in a public housing unit (HUD)	The client has moved into a VHA-subsidized property where the subsidy is attached to the property, not the client (e.g. if the client moves to another apartment, their rent will no longer be subsidized)
Rental by client, no ongoing housing subsidy (HUD)	The client has moved into their own rental and has no ongoing program that is assisting with their rent.  This includes households that accessed some form of assistance with move-in costs through diversion  - This also includes clients who leave to join the military and clients who leave to join a service corps
Rental by client, with GPD TIP housing subsidy (HUD)	Client has entered a grant-per-diem transition-in- place veterans' program
Rental by client, with HCV voucher (tenant or project based) (HUD)	The client has moved into a rental where they are using a Section 8 voucher or other housing choice voucher

Rental by client, with other ongoing housing subsidy (HUD)	The client has moved into a rental and they have some form of ongoing rent assistance that does not fall in any other category (this is rare)		
Rental by client, with RRH or equivalent subsidy (HUD)	The client is in a rapid re-housing program and has moved into a rental unit		
Rental by client, with VASH housing subsidy (HUD)	The client is in VASH and has moved into a rental unit, either location-based or scattered-site		
Residential project or halfway house with no homeless criteria (HUD)	The client has moved into an Oxford House or a similar residential program that does not require homelessness and does not fill openings through coordinated entry		
Safe Haven (HUD)	Unused in Clark County—we have no safe havens. Safe Havens are essentially like if the Navigation Center had drop-in bunk beds that were open 24 hours, with no maximum residency time limit		
Staying or living with family, permanent tenure (HUD)	The client is staying with a family member and believes they will be able to stay as long as they wish.  - This counts as a permanent exit, but if they return to the system it will count as a return from housed		
Staying or living with family, temporary tenure (HUD)	The client is staying with a family member and believes it is a temporary situation that they will need to leave  - This does not count as a permanent exit, but if they return to the system it will not count as a return from housed		
Staying or living with friends, permanent tenure (HUD)	<ul> <li>The client is staying with a friend and believes they will be able to stay as long as they wish.</li> <li>This counts as a permanent exit, but if they return to the system it will count as a return from housed</li> </ul>		
Staying or living with friends, temporary tenure (HUD)	The client is staying with a friend and believes it is a temporary situation that they will need to leave  - This does not count as a permanent exit, but if they return to the system it will not count as a return from housed		
Substance abuse treatment facility or detox center (HUD)	The client is currently admitted to a detox or rehab center and is expected to be there at least the night of program exit		
Transitional housing for homeless persons (including homeless youth) (HUD)	The client has entered a transitional housing program and has moved into their unit
