PET FOOD BANKS

Humane Society for Southwest Washington CHOW Program

is a program for families in SW Washington in need of temporary assistance feeding their pets. Pet food is currently available to any family or individual in need of assistance. CHOW pet food is available during regular business hours at HSSW's Admission area and at the ReTails Thrift Store. HSSW works closely with food banks and pantries, and organizations serving those in need to ensure pet food is readily available throughout our community. VETERINARY ASSISTANCE

The Portland Animal Welfare (PAW) Team

Safe Haven

HSSW provides emergency boarding assistance for families of Clark and Skamania counties. The program provides relief for families facing a temporary hardship or displacement due to domestic violence, emergency medical issues, and other urgent needs that prevent them from caring for their pet. Approval is dependent on available space and cannot be guaranteed. EMOTIONAL SUPPORT ANIMALS IN HOUSING

An emotional support animal is not a pet. An emotional support animal is a companion animal that provides therapeutic benefit to an individual with a mental or psychiatric disability. The person seeking the emotional support animal must have a verifiable disability (the reason cannot just be a need for companionship). The animal is viewed as a "reasonable accommodation" under the Fair Housing Amendments Act of 1988 (FHA or FHAct) to those housing communities that have a "no pets" rule.
