Connections is a program that utilizes a housing first model to assist 18-25 year-old youth and families who have a disability and are experiencing chronic homelessness to obtain and maintain permanent housing. Providing early intervention services to youth experiencing chronic homelessness can reduce harm on an individual and community-wide level. Without permanent supportive housing, youth who are impacted by disabilities, severe and persistent mental health challenges, chronic substance use, and institutional marginalization, youth will remain vulnerable to the dangers and health risks of living on the streets. Rather than allowing youth in these situations to be further pushed to the fringes of the Clark County community, the Connections program seeks to immediately provide permanent housing coupled with voluntary case management services.

Strength-based services that address key barriers to housing can prevent the revolving door of homelessness. Connections services will include indefinite rental assistance and voluntary and flexible case management services tailored to meet individualized client needs.

Helping youth access and maintain permanent, affordable housing is foundational to the Connections design. The program works in close collaboration with The Perch drop in center and Yellow Brick Road Outreach, two Janus programs specifically designed to meet the needs of youth experiencing homelessness in Clark County. According to data collected by these two community partners, there are approximately 91 youth experiencing chronic homelessness in Clark County. Janus Youth's Washington based housing programs, Nest and Bridges, have worked directly with these high-risk youth providing rental assistance and intensive case management services. Connections staff members will also work closely with community providers in order to connect interested participants with outside resources to promote longterm self-sufficiency.

There is currently a severe lack of youth-focused services in Clark County specific to the issues of chronic youth homelessness. The Connections program has been filling this gap in community services. Thus, CoC program support would offer an opportunity to carry out the financial component of addressing the issue of chronic homelessness and the need for permanent housing among youth.


